He explained that the intent of the proposed Side Letter is to modify the Preamble of the memorandum of understanding (MOU) between the Management Confidential Bargaining Group and the Authority dated July 1, 2016 through June 30, 2019 to clarify the job classifications covered by the MOU and their associated salaries in Appendix A.
